

2016 Salt Lake City Research Trip—22-29 May 2016!

Orientation: Monday morning, 23 May, 8:15 am in the room off the library lobby

Accommodations--Reservations are now being taken at the **Plaza Hotel in Salt Lake City**, with arrivals on **Sunday, May 22** and departures on **Sunday, May 29**. (Call toll free [800-366-3684](tel:800-366-3684).) Rooms are booked under the name "**The San Jose GenBuds Study Group**", and you **MUST** mention the group name to get the group rate/be identified as part of this group. Reservations must be made by 20 March 2016 to ensure the group rates.

If you want to arrive a week early, you can make reservations from Sunday, May 15th through Saturday, May 21st, at our preferred rates. To reserve a room for the week prior, call Rich Williams, Director of Sales, directly at [801-606-2410](tel:801-606-2410) and mention the San Jose GenBuds.

The full week following the official week is also available at the group rate.

Room Rates--\$87 for 1-2/room; \$94 for 3-4/room. Roll away beds are extra. The rooms on the front of the hotel are now designated as *Deluxe* rooms and will be \$10 per night extra. *Standard* rooms are smaller, have only one sink, and you do not have a table and chairs. Deluxe rooms are larger with two sinks and a table and 2 chairs.
